

SECTION VI: FACTS THAT ESTABLISH PROBABLE CAUSE

A. I, J.A. Young (Affiant), am a law enforcement officer with the Cary Police Department holding the rank of Senior Police Officer. I have been employed as a law enforcement officer with the Cary Police Department since 1994 with the exception of the time period of 1997 to 2001 when I was employed as a law enforcement officer with the Greensboro Police Department. I received my Advanced Certificate from the North Carolina Criminal Justice Training and Standards Commission in November, 2000. I am currently assigned as a Detective with the Criminal Investigations Division of the Cary Police Department. Prior to my assignment as a Detective, I investigated and arrested individuals regarding numerous incidents of breaking and entering to businesses and residences, larceny offenses, possession of stolen property and traffic offenses as an officer assigned to the Field Operations Bureau of both the Cary Police Department and the Greensboro Police Department. Since my assignment as a Detective in January, 2005, I have investigated and arrested individuals regarding the criminal offenses of attempted murder, assault with a deadly weapon with the intent to kill, armed robbery, rape, sex offenses, financial crimes and drug crimes. I have more than 1,400 hours of law enforcement training which includes advanced training in the investigation of natural deaths, suicides and homicides.

B. On Saturday, July 12, 2008, the Cary Police Department initiated an investigation regarding a 'missing person', Nancy Lynn Cooper, who was last seen at the residence of 104 Wallsburg Court, Cary, N.C. which she shared with her husband, Bradley (Brad) Graham Cooper and their two (2) children.

On Monday, July 14, 2008, a body was located by a resident of Wake County, North Carolina lying face down in a 'drainage pond' in an undeveloped phase within 'The Oaks at Meadowridge' subdivision, which is located in close proximity to the 4700 Block of Fielding Drive, Raleigh, North Carolina in Wake County and reported to the Wake County Sheriff's Office. The body was determined to be that of a white female, who was deceased. The deceased white female had died as a result of 'suspicious circumstances'

based upon a joint investigation by the Wake County Sheriff's Office, the Cary Police Department, the City-County Bureau of Identification (Wake County) and the Office of the Chief Medical Examiner.

On Tuesday, July 15, 2008, the deceased white female was identified as Nancy Lynn Cooper by Dr. John Butts, the Chief Medical Examiner for the State of North Carolina. The manner of death was determined to be a homicide based upon the preliminary autopsy which was completed on that date.

During interviews with numerous friends, to include Jessica Adam and Diana Duncan, Cary Police Detective G. Daniels, Cary Police Detective A. Dismukes and affiant learned that Nancy Cooper was seeking a divorce from Brad Cooper due to an admission of an extramarital affair with another female. In addition, individuals interviewed provided statements regarding an additional extramarital affair by Brad Cooper involving a female whom Brad Cooper met while attending graduate school and visited while overseas during the course of his employment with Cisco Systems, Inc. in February, 2008.

A search warrant for the residence of Brad and Nancy Cooper at 104 Wallsburg Court, Cary, North Carolina (Wake County) was executed on July 16 and 17, 2008. Documents believed to illustrate marital discord were located during the execution of the search warrant and seized pursuant to the search warrant. In addition, a IBM Thinkpad laptop computer (serial number _____), a HP XW4400 Workstation tower (serial number _____), a Dell Dimension 8300 tower (serial number _____), a MacBook Pro laptop computer (serial number _____) and a Maxtor external hard drive (serial number _____) were seized from the interior of the residence pursuant to the search warrant due to these items believed to contain information pertaining to the homicide of Nancy Lynn Cooper or illustrate and/or provide evidence of marital discord of Bradley and Nancy Cooper.

On July 21, 2008 a search warrant was executed at the office, identified as R3-317 in Building #9 at 7100 Kit Creek Road, Morrisville, North Carolina, of Bradley Cooper at Cisco Systems, Inc. A Cruzer Micro 2.0 GB thumb drive (model _____) and a Western Digital external hard drive (serial number _____) were seized pursuant to the search warrant due to these items believed to contain information
