


**PROBABLE CAUSE AFFIDAVIT:**

2. This investigation concerns the physical child abuse of four year old Teghan Reyes, which was reported to the Johnston County Sheriff's Office on Friday, July 16, 2010 on or about 1:04 p.m. On Friday, July 16, 2010 Jonathan Douglas Richardson took Teghan Reyes to Johnston Health in Smithfield, N.C. to be treated for injuries. At that time authorities were notified of possible child abuse of Teghan Reyes. Detective Don Pate and Jamie Snipes went to Johnston Health and gathered information from medical staff that Teghan Reyes had been physically abused. Detectives observed on the body of Teghan Reyes multiple scrapes, cuts, lacerations, bruises, and what appears to be human bite marks. Teghan Reyes was transported to UNC Hospital due to her injuries. Detective Lieutenant Chris Otto spoke with medical personal at UNC Hospital by telephone and they told him that Teghan Reyes had \_\_\_\_\_ and injures to her \_\_\_\_\_ area. 3. (Continued) Since this time Jonathan Douglas Richardson has been the sole care provider for Teghan Reyes. Jonathan Douglas Richardson told Detective Jamie Snipes that on Wednesday, July 14, 2010 that Teghan Reyes, who sleeps in the same bed with him at night, urinated and defecated on him. Jonathan Douglas Richardson stated that he became upset when Teghan Reyes urinated and defecated in the bed. Jonathan Douglas Richardson told Detective Jamie Snipes that he "lost it" and whipped Tegahn with a drop cord. Jonathan Douglas Richardson also stated to Detective Jamie Snipes that he was bipolar and little things set him off.

4. This Affiant check NCIC (Criminal History) on Jonathan Douglas Richardson and discovered that on October 24, 2007 Jonathan Douglas Richardson was charged with Injury to Real Property.
