

AFFIDAVIT

RUSSELL MILLER CARTER, first being duly sworn, deposes and says:

1. I am the President of Atlantic Corporation.
2. I have caused Atlantic Corporation to reimburse or provide bonus funds to employees of Atlantic Corporation for the purpose of such employees making political contributions at my direction. The referenced contributions made at my direction have been to North Carolina and federal political committees. To the best of my knowledge, Attachment A (pp. 1-14) accurately reflects the contributions made by employees of Atlantic Corporation that were either reimbursed by Atlantic Corporation to the employees or bonus funds provided by Atlantic Corporation to the employees for the purpose of making the contributions. All such contributions, reimbursements, and bonus funds were made or provided at my direction. I have no access to records regarding funds provided by Atlantic Corporation prior to January 1, 2004, but believe the contributions reflected in Attachment A which predate January 1, 2004, were either reimbursed by Atlantic Corporation or bonus funds were provided.
3. Wesley Carter, Ellen Carter and Elizabeth Carter are my children. I have deposited my personal funds into the checking accounts of Wesley Carter, Ellen Carter and Elizabeth Carter for the purpose of making political contributions at my direction. To the best of my knowledge, Attachment B accurately reflects the contributions made by Wesley Carter, Ellen Carter and Elizabeth Carter that were made with my personal funds and at my direction.
4. To the best of my knowledge, and subject only to the caveat noted above for pre-January 1, 2004 contributions, Attachment C accurately reflects total contributions made by various individuals with funds provided by Atlantic Corporation to North Carolina political committees and federal political committees through employees of Atlantic Corporation at my direction.
5. To the best of my knowledge, Attachment D accurately reflects total contributions made with my personal funds to North Carolina political committees and federal political committees in the name of others at my direction.
6. I have never, directly or indirectly, stated, implied or suggested to any candidate, political committee, candidate committee, political party, or any officer, employee, or agent of such candidate, political committee, candidate committee, or political party, that I or Atlantic Corporation was reimbursing or providing bonus funds to employees for the purpose of making contributions to any candidate, political committee, candidate committee, or political party.

7. No person or individual has ever advised, stated to, informed, instructed, suggested to, or implied to me that Atlantic Corporation's or any other corporation's reimbursing employees or providing bonus funds to employees for the purpose of making political contributions was a valid, lawful, or appropriate means of making contributions to candidates, political committees, candidate committees, or political parties at either the State or federal level. In addition, no person or individual has ever advised, stated to, informed, instructed, suggested to, or implied to me that I could or should contribute to any candidate, political committee, candidate committee, or political party by using Atlantic Corporation's or any other corporation's funds to reimburse employees or providing bonus funds to employees for the purpose of making political contributions.
8. I have been told that with respect to making contributions to North Carolina political committees, your wife, kids, dogs and cats can all make contributions. I do not know who made this statement to me. Additionally, I do not know which campaign the individual worked for or in which election time period the statement was made to me.
9. To the best of my knowledge, Attachment E accurately reflects contributions I have made to candidates, political committees, candidate committees, and political parties based on filed reports with the State Board of Elections. These contributions were made with my personal funds and not the funds of any other individual or entity.
10. No person or individual has ever advised, stated to, informed, instructed, suggested to, or implied to me that my monetary contribution to the North Carolina Republican Party, in whole or in part, would or could be used exclusively, primarily, or substantially (or words to this effect) for the benefit of a specific or particular candidate or candidate committee.
11. No person or individual has ever advised, stated to, informed, instructed, suggested to, or implied to me that my monetary contribution to the North Carolina Democratic Party, in whole or in part, would or could be used exclusively, primarily, or substantially (or words to this effect) for the benefit of a specific or particular candidate or candidate committee.



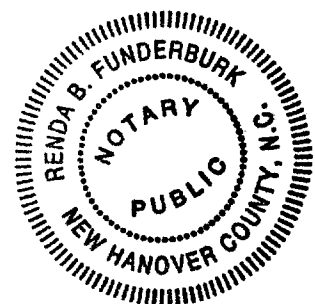
